Special Emergency-Disaster Public Town Board Meeting Thursday, June 16, 2022

Call to order: The meeting was called to order by Chairman Bruce Weber at Noon. The Pledge of Allegiance was recited.

Verification of proper public notice: Agendas were posted 6/15/22 on Silver Cliff Website and at Silver Cliff Town Hall, and Red Pine BP.

Motion to Approve Agenda Items: Supervisor Dee Farley motioned it, seconded it by Supervisor Sue Victoreen. Motion Carried.

Discussion and possible action regarding Emergency Disaster of Town of Silver Cliff, Town

Property/Buildings: Chairman Bruce Weber=Severe weather, thunderstorm and power outage event occurred 6/15/22, today special meeting to officially declare emergency disaster of Town of Silver Cliff. Declaration Disaster Proclamation pursuant to Wis. Stat. #323.14 (3) & (4) and the Marinette County Code of Ordinances, Chapter 6 Emergency Management (6.04) proclaim a State of Emergency in effect until further notice. Motioned by Supervisor Dee Farley, seconded by Supervisor Sue Victoreen. Motion Carried.

Notified DNR-debris management plan, will have designated debris areas. Insurance Company has been contacted. All of our buildings have extensive damage to them. Power outages, a lot of tree damage. Reported no injuries or fatalities. We have done numerous wellness checks on residents. Volunteer Safety Officers/coordinators are Al Walesh and Jeff DeBauche, primary concern is safety. Log in sheets-write time in/out and equipment used/location-need to keep track of volunteer time for emergency disaster funding request. 2 of Fire trucks are not usable/damaged from storm, borrowing 1 Stephenson Fire Truck & 1 Crooked Lake Fire Truck. Thank you. Recycling/Garbage Bins are good-can't drive thru, but can accept it.

Public Comment: Chairman Bruce Weber=Donations of Food and Water can be brought to Town Hall as hub. Town Hall will be open 24 hours for if any one needs to use bathrooms/bottled water or food. (Will have generator going) Also we are having a portable potty located outside town hall. Located at Jungle Jims parking lot is temporarily a refrigerated truck for use of perishables. We are updating Town of Silver Cliff Website with additional information.
