

**Town of Silver Cliff Meeting Minutes for Annual 2023 Budget Hearing & Special  
Elector's Meeting**

**Held on November 29, 2022 6:00 PM**

***Call annual budget hearing to order:*** The budget hearing was called to order by Chairman Bruce Weber at 6:00 pm. The pledge of allegiance was recited. Chairman Weber asked everyone to please make sure they signed in.

**Verification of proper public notice:** Verified it was properly noticed in Peshtigo Times, Town Website, Town Hall, Town Shop, and Red Pines BP.

**Review Budget Line Items:** Chairman Bruce Weber reviewed the changes in revenues and expenses for 2023, the big difference was insurance revenues from the tornado/storm damage the town incurred, so we estimated as best as possible. The Town Board proposes to use the Debt amount of the Town Loan payment amount of \$72,000.00 to be added to the 2022 Tax Levy for the next year a 1 year term. The 2022 Tax Levy limit before adjustments is \$128,368.00 Adding the \$72,000.00 Debt amount=\$200,368.00 as the Proposed 2022 Tax Levy Amount. Each year this would need to reviewed and would need authorization. In the past few years we have taken money out of Town money market accounts and CD's to offset the loan debt payment amount. 2023 Roadwork proposed is remaining 4,000 feet of Old J and work on Kimball Lane 3,643 feet. Town Hall and park crack sealing. Chairman Bruce Weber asked if any questions of the people on the 2023 budget review there were No questions.
