- 1. Call to order & Pledge of Allegiance: Meeting called to order at 7:00 pm, by Chairman, Bruce Weber. The Pledge of Allegiance was recited.
- Roll call: Present, Chairman, Bruce Weber; Supervisor, Dee Farley; Supervisor, Jay VanFrachen, Treasurer, Carol Kitchmaster; Clerk, Amy Vannieuwenhoven; Code Enforcement Officer, Cory Gagne. Verification of proper public notice: August 2, 2023, 12:15 p.m.
- 3. Motion to Approve the Agenda: Motion by Supervisor, Dee Farley, seconded by Supervisor, Jay VanFrachen. Motion carried.

Consider for approval or other action:

- Approval of the meeting minutes for the July 11th, 2023 Town Board Meeting, after any corrections have been reflected: After a correction to the permit cost increase from \$50.00 to \$75.00, minutes approved. Motion by Supervisor, Dee Farley, seconded by Supervisor, Jay VanFrache. Motion carried.
- Discussion and possible action for the Community Development Block Grant Administration agreement. MSA in attendance via phone to address the board. Discussion how grant reporting will be done. Motion made by Supervisor, Jay VanFrachen, seconded by Supervisor, Dee Farley. Motion carried.
- 6. Discussion and possible action regarding the contract for garbage pick-up. Representatives of JNS did not appear at the monthly meeting to address the board. JNS is increasing the garbage collection fee from \$1750.00 per month to \$\$3500.00 per month and the per trip fee for yardage containers from \$250.00 to \$300.00 and \$150.00 to \$215.00, as two pick up trips per week are now needed. Proposed annual \$50.00 fee for properties within the town, with improvements. This fee would cover the cost increase. Motion by Supervisor, Dee Farley, seconded by Supervisor, Jay VanFrachen. Motion carried.
- 7. Discussion and possible action to purchase a new water heater for the town hall. The water heater in the town hall is not in working order. Would like to transition back to a traditional water heater from an "on demand". Supervisors to gather bids for purchase and installation.
- 8. Discussion and possible action regarding resignation of the Town of Silver Cliff Constable, and recruitment to fill the position. The current Constable has met the \$15,000.00 town wage limit and will step down as of August 14th, 2023. Recruitment will be open for one week via a notice in the Peshtigo Times and town website. Appointment of a new Constable will be addressed at the September 2023 Town Board Meeting.
- 9. Discussion and possible action regarding the bids to paint the town hall. This item is tabled until Spring of 2024. Possible to rebid for just the painting of the trim.
- Discussion and possible action regarding the propane contract with Northwoods. Cost of propane was \$1.71/lb. in 2022, cost is \$1.479/lb. for 2023. Motion by Supervisor Jay VanFrachen, seconded by Supervisor, Dee Farley. Motion carried.
- 11. Discussion and possible action regarding the Planning Commission's recommendation of the CSM map for Michael Drexler. Silver Cliff Planning Commission recommends approval of the CSM map for Michael Drexler. Motion by Supervisor Dee Farley, seconded by Supervisor, Jay VanFrachen. Motion carried.
- Discussion and possible action to increase the residential building permit fee to \$75.00. The current cost of non-dwelling residential permits is \$20.00. Proposal to increase the cost to \$75.00 effective September 1, 2023. Motion by supervisor, Dee Farley, seconded by Supervisor, Jay VanFrachen. Motion carried
