- 14. Approve a \$2500.00 fine for the brick mason doing work at the EMS building, for breach of contract: Work done by a contracted mason for the EMS building was done incorrectly and against the contractor's specification sheet. Motion to approve a \$2500.00 fine for the contracted mason work for the EMS building due to the contractor going against the contract, made by Supervisor Dee Farley, seconded by Supervisor Jay Van Frachen, motion carried.

## 15. Reports / Updates presented:

- a. Treasurer's report: Bank balances, checking \$26,191.03, money market \$87,883.59, tax account \$91,491.16, state funds (EMS) \$83,838.99 and interest earned \$8,831.73. CD's are coming due and will roll at 5%.
- b. Chairman report: A letter writing campaign to the Governor's office is complete, the ask is for \$500k additional funds to finish the EMS building construction. The Broadband committee is in talks with Insight. There has been damage done to the EMS building area due to the public entering the construction site. From now on, permission from a town supervisor must be given before the public will be able to enter the construction zone. An update on construction progress was given. Reminder, WTA County meeting in Amberg, September 19<sup>th</sup>, 2024.
- c. Planning Commission: The commission is making tweaks to the dog control ordinance, replacing dog with animal and the building permit ordinance to remove the under \$1000.00 language (no permit needed). The town board directs the commission to make these changes.
- d. Supervisor Reports: Dee has had multiple garbage collection inquiries, a driveway question and inquired about the land behind The Rustic being turned into a conservancy. Jay is dealing with a property owner not obtaining a permit to put a shipping container on their property and received a call about what hospital a patient is transported to by the rescue squad.
- e. Fire Department: The month has been slow. There is a driver operator class scheduled in October.
- f. Marinette County Supervisor, Chris Norton: Chris gave updates from Marinette County.
