### July 9, 2024 Silver Cliff Town Board Meeting Minutes

- 1. Call to order and Pledge of Allegiance Meeting was called to order by at 7 and the pledge of allegiance was recited.
- 2. Roll call and verification of proper public notice. Those present were Bruce Weber, Dee Farley, Jay Van Fracken, and 17 citizens.
- 3. Motion to Approve the Agenda Motion was made by Dee and second by Jay, motion carried.

### Consider for approval or other action:

- 4. Approval of the meeting minutes for the June 10<sup>th</sup> Special Town Board meeting & the June 11<sup>th</sup>, 2024, Town Board Meeting.
  - a. A motion to approve June 11<sup>th</sup> special meeting was made by Dee and second by Jay, motion carried.
    - b. A motion to approve June 11<sup>th</sup> regular town board meeting was made by Dee and second by Jay, motion carried.
- 5. Discussion and possible action to revise the SC Community Center rental agreement (form 00113).
  - a. Discussion and action: approved at prior board meeting, concerns with needing to include name, type and date of events, address, resident total deposit received and add the changes. Motion to accept the changes that were made by Dee second by Jay, motion carried.
- 6. Discussion and possible action to approve the transfer of state approved CDBG funds within 3 days of receipt to Laona State Bank CDBG checking account to Laona State Bank town checking and issue a cashier's check to Bayland Buildings as payment of services for the emergency services building. (This per CDBG compliance requirements)
  - a. Discussion/ motion: Bruce talked about how the account that we set up per instructions. Now we had to transfer the money out of the account into the town account and then send it to the vendor and not sure how we will do it in our books. They issued a cashier's check out of the CBDG account to the vendor so the money was out of the account right away. Cashier's check may take care of this situation instead of jumping from one account to the next.
- 7. Discussion and possible action to reschedule the date or move the meeting location of the August 13<sup>th</sup> town board meeting, due to the town hall being used for the Wisconsin Primary Election.
  - a. Discussion/ action: Election same day as the election, options change date of meeting or move the meeting. It was decided changing the day to August 12<sup>th</sup> due to elections was the best solution. Also, mentioned that reviewing the ballots prior to voting would be prudent because the ballot is confusing and questions can be addressed ahead of time.
- 8. Discussion and possible action to adopt a record retention ordinance for security cameras until clarified.
  - a. Discussion/ motion: There was a presentation by WTA Jake and we asked about the length of time we need to keep video/ surveillance found in WMRS pg. 46 so, where we have security cameras those

recordings need to be saved for 4 months. Also, should be done for board of review, right now you cannot release them before 120 days. We will review how the cameras work and if they loop. You could also use a server but it would be an added expense. Because it is a public record, we need to see how to preserve the recordings.

9. Discussion and possible action to revisit the town of Silver Cliff Employee Handbook and employment policies. Specific to vacation carry over. It has been allowed to carry over vacation without any limit. But according to our handbook we need to revisit the policy for no more than a two-week amount and very few reasons for us to carry over more than two weeks. Sick day policy and it says that they can accumulate up to 600 days to carry over. 1 sick day per month. Page numbers are off also, scheduling a meeting to address the issues and the last time it was reviewed was in 2013, this meeting will be open to the public.

10. Adoption of revised ATV ordinance 081022.1 with 070924.2

- a. Sabin presented information stating we would open our roads 24/7 and we did add a reckless clause so that anything the driver did that was not responsible behavior liability would fall on the driver on page 3. No strobe light, one red light one break light, etc. that were in the clause. Land owners who agree to have trails on their land they are liable. Signed by Dee, Jay, 081022-1 ordinance number by the county will be adopted. A motion was made by Dee and second by Jay motion carried.
- b. Any amendments: We need to post it in the paper. The town is responsible for this signage so, we will need to change or remove our old information and times for riding.
- 11. Discussion and possible action regarding possible progress with assessor ads
  - a. Discussion? Our progress is 0 and we ran it for 3 weeks, no one wants to take this position on right now. We do not have one at this point and all the large assessment companies an Mersau will be here and we will talk to him about this situation. We have permits and revenue but need to get them on the tax roll, no other progress.
- 12. Discussion and possible action regarding the shop foreman resumes and scheduling of interviews
  - a. Discussion? 3 weeks ran in paper, 5 resumes were very good and very qualified folks, we did send out applications to all of them and we hope to get those apps back. We plan on having the interviews over the next few weeks
