There was some discussion about possibly purchasing an aluminum ramp from a private party and Supervisor Jim Fencil said he would have to check measurements and costs. Chairperson Dee Farley said she had spoken to Sam Greenburg regarding the planting of trees in the park, unfortunately his organization had lost their funding, but he suggested another organization that would plant trees for us if we purchased the trees. Chairperson Dee Farley is also pushing to get grants to offset the cost of trees. Due to changes within the recycling center Supervisor Jim Fencil wants to hire a few more recycling attendants. Both Supervisors agreed that posting the agenda a week prior to the meeting is frustrating because there are often changes that need to be made to the agenda. According to Wisconsin Town’s Association legally we need to post publicly the agenda 24 hours prior to the meeting. Supervisor Jim Fencil said that he had contacted the guy regarding the town shop roof to get the roof repaired from leaking, he came and did somethings and said he would be back when it rains but he never returned and it is still leaking, the road crew foreman will be contacting him.
