#### Minutes

- 1. Call to order by Chair Dee Farley followed by the Pledge of Allegiance
- 2. Roll call: Chair Dee Farley, Supervisor Jim Fencl, Supervisor Scott Volkmann, Treasurer Carol Kitchmaster, Clerk Lisa Weinrich, Data Specialist Riana Ventura, Public Laura Fencl; Verification of Meeting Notice was posted at the Red Pine BP, Town Hall, Town Website
- 3. Discussion and review items for the 2026 budget
- 4. Riana started the meeting off with an explanation of the reports that she presented
  - a. Bank Balances- To know where you are at you have to know where you are starting and these are good to October 1st
  - b. Revenues collected in 2025- This will help you anticipate what will be coming in such as taxes and other income and how much is going out
  - c. Garbage- there is an issue with garbage, we collect a lot of money, and it's not spent on garbage, somehow it is disappearing in the budget system and is not being spent on garbage or recycling. You cannot collect money for one thing and spend it on something else
    - i. Special Assessment money only goes to that program this is in addition to the town
    - ii. Normally the money that was collected in December should have been moved from the liability account, but it was not moved, which is why things are such a mess
  - d. Expenses are difficult because they are co-mingled with fire department
  - e. Expense report shows we pay of the schools, the county, and NWTC
  - f. Town brings in \$1.85M, we immediately chop off \$1.277M to pay our dues, we collect money and the county collects money for us. We do not get to keep the \$1.85M we only get to keep \$580,000
  - g. To spend more than \$580,000 is to answer 3 questions:
    - i. What is the anticipated Tax Levy above the 2025 figures
    - ii. Look at shared revenue from 2025 and look at what you anticipate for 2026 then subtract and the difference because the 2025 is established
    - iii. The County will give you an estimate of property taxes
  - h. Riana suggested that we take any money that is not being spent in the next couple months and put it in Money Market CD and start making money off of money
  - i. Town Shop we also collected money to pay for that but we appear to be collecting more than what we are also spending on that but she needs to confirm that
    - i. We owe about \$350,000 loan out for the shop
  - j. Just fill in the changes and anything that needs to be updated as soon as possible to balance the budget. Fill in the boxes on the spreadsheet presented
