Assessor – Elizabeth Polacheck introduction and sign contract: Elizabeth “Beth” Polacheck introduced herself and spoke to everyone in attendance about her plans as our New Assessor to try to visit as many properties as possible, we will be going through an evaluation which has not happened since 2002. Beth also explained that she does not have to enter a dwelling but will do an evaluation of exteriors and feels due to the amount of time that has passed since the last evaluation that many properties may be charged for improvements that may not be applicable and the tax payer is paying for those improvements so she just wants to get everything updated, she has green tags that she will leave if she misses you so you are aware that she was there. Beth also stated that there will be a written notice of the evaluation. Additional contact information is available from the board, treasurer, and clerk.
7. Roaring Rapids Development Update - Supervisor Scott Volkmann drove back there and saw a surveying group so he inquired about the status and he was informed that the road was completed. Supervisor Jim Fencl remarked that the road can't be done; we didn't vote on anything regarding the road. Roadcrew Foreman Jeff DeBauche said he drove back on that road with the one ton after a rain and he sank down almost 3 inches, imagine having a semi's drive back there loaded down with building materials. Chair Dee Farley stated that we have no control over the road, it is not our responsibility, they never built that road to the Town of Silver Cliff's specifications. Sue Victoreen informed the board

about the 3 year rule that the State has, which states that if we do not touch a road for three years it will revert back to the developer who built the road.

8. Insurance: Chair Dee Farley stated that we have received our payment of \$255,000 which has been deposited. (Amended)
9. Exploring options for new Town Insurance - Chair Dee Farley called several institutions about insurance and waiting for a response from all except one which we are filling out the application for now. Supervisor Jim Fencl asked about the time frame to get new insurance, Dee replied 60 days.
10. Repairs on Community Center vestibule and other areas - Chair Dee Farley stated that she had Over Head Solutions come in to look at possible repairs of the vestibule, she was then informed that they do not do these kinds of repairs. Supervisor Jim Fencl said that he had gone over to try to figure out what all needs to be addressed and mentioned a few things that we should have looked at for safety sake. Supervisor Fencl also mentioned having the prints for the building would be helpful, Clerk Lisa Weinrich told him that we have the prints available just need to know when they want to see them.

Reports/ Updates

11. Supervisor 1 Report - Supervisor Jim Fencl stated that he looked into the expanse of our disability ramp that is extremely close to code and the aluminum ramp that we were considering to replace our wooden which was built in the 90's, which should work. It was also noted that there were several pot holes on Klug Lane that were taken care of.
12. Supervisor 2 Report - Supervisor Scott Volkmann who is also on the Broadband Committee stated that he found Spectrum is going to start blanketing the area and hopefully bringing high speed to us soon.
13. Treasurer's Report - Checking Balance is \$29,898.12; Money Market \$219,759.55; CD \$48,773.22; Fire Department Treasurer's Report - Checking: \$5,784.89; Money Market:\$47,133.94; CD: \$27,285.17; Balance: \$103,220.65
14. Constable's Report - Sabin Rosenbaum stated that we had a dog in Doggie Jail for about a week, a sad situation and it is believed that the dog was abandoned, nice dog but not house trained so he had to take it to, Almost Home Animal Shelter, the only shelter taking dogs at this time. Not too much other than that.
15. Planning Commission Committee Report - Sabin Rosenbaum stated that they had joint meetings in Athelstane and Amberg; He also stated that Oconto County has a new ordinance for Short Term Rentals; There was no conclusion to the weight limit ordinance yet; Hardwood LLC issue was completed
16. Recycling Committee Report - Supervisor Jim Fencl asked Jeff DeBauche to move the mattresses
17. Cemetery Committee Report - Sexton Sue Victoreen stated that they sold a family plot and how nicely it was maintained

Road Status Report - Road Crew Foreman Jeff DeBauche stated that the sand/salt mix for winter is ready and set to go; 09 is getting pretty bad mechanically; Water for the old town shop does not have a shut off and there was concern of it freezing after consulting a plumber it was determined that they would wrap the pipes with heat tape where it comes out of the building, they were hoping to get a shut off installed but not sure if there is a shut off here in the town hall and they will look into it some more but that is a solution for now; Brush mower is back up and running fine so getting a lot done with it now; Kasey is having back surgery and Jeff is having hip surgery so we will be down a couple guys for a while; Paul Whiting will only do emergency snow plowing
20. Fire Department Report - Dan Simmers stated that there was one call without a burning permit and the DNR asked us to put it out which we did; Need a fire inspection for the community center, fire extinguishers need to be updated; Community Center needs first aid kit also
