NOTICE OF ANNUAL ELECTORS' MEETING

Sign in on arrival. Any qualified town elector may vote at the annual meeting. Wis. Stat. § 60.14(1). This means that the person must be a U.S. citizen who is at least 18 years old, has resided in the town for at least 28 consecutive days prior to the meeting, and is otherwise eligible to vote in the town or listed in the Poll Book. Someone who owns property in the town; but is not a permanent resident would not be permitted to vote. Additionally, proxy or absentee voting are not allowed at town elector meetings.

AGENDA

1. Chairman calls the Meeting to Order
2. Pledge of Allegiance
3. Reading and Approval of Meeting Minutes from April 16th 2025.
4. Statements for the Financial Condition of the Town as pursuant to Wis. Stat. § 60.41.(All Reports and Accounts relating to Audit for 2025)
5. Approval of Audit and Financial Reports
6. Motion for how votes will be cast. (voice, hands or by paper ballots.) Must initially be a show of hands for how votes will be recorded.
- 6.The floor is open to electors for motions.

(a.)Suggestions and comments can be made by anyone. Please limit speaking to 3 minutes per instance.

(b.)If motion is made. Clerk needs to record exact wording of motion and whom has made it, who seconds it and the time it was complete for the beginning of voting. Please come to the podium for making motions. State your name, if you are an elector and the exact wording of the motion.

(c.)The town electors at the annual meeting may only **take action** on the items they are authorized to act on by state law, as outlined in Wis. Stat. § 60.10. The town chair and board members should prepare for the annual meeting by familiarizing themselves with the items listed in § 60.10 so that any confusion regarding which topics the electors do and do not have direct authority over can be clarified. Powers of Town Meeting § 60.10 will be available to participants at electors meeting along with other pertinent materials.

- 7.Motion to adjourn the meeting to following year determined by the people to be held on the 3rd Tuesday of April OR another day and time authorized by the people.
