ORDINANCE # 51485B

ORDINANCE REGULATING HOURS OF USE OF BOAT LANDINGS ON TOWN PROPERTY COMMONLY REFERRED TO AS "THE FARM DAM". ALSO THE PROHIBITION OF TAKING CANS, SACKS, BOTTLES, CONTAINERS, OR FOODSTUFFS IN ANY TYPE OF WATER-CRAFT USING THESE LANDINGS. ALSO THE PROHIBITION OF CAMPING OR CAMP FIRES.

The Town Board of the Town of Silver Cliff, County of Marinette, State of Wisconsin, do ordain as follows:

## SECTION 1. DEFINITION

- A. "FARM DAM": That portion of land owned by the Town of Silver Cliff in Section 22, Town 34 North, Range 17 East.
- B. BOAT LANDINGS: That portion of land used by the public to gain access to the Peshtigo River and a portion of the Otter Creek.
- C. WATERCRAFT: Any type of raft, boat, inner tubes, canoes, or Kayaks.

## SECTION 2. HOURS OF USE

- A. The hours of use to gain access to the Peshtigo River and Otter Creek by persons using watercraft shall begin daily at 9:00 a.m. until 4:00 p.m.

## SECTION 3. PROHIBITION

- A. No camping or camp fires will be allowed on this property.
- B. No littering of garbage, papers or cans shall be allowed on this property.

C. No can goods, sacks, bottles, foodstuffs, or containers may be taken aboard any watercraft using these landings.

SECTION 4. EXCEPTION

A. No variance or exception to this ordinance will be allowed unless permission is granted in writing by the Town Board.

SECTION 5. SEPARABILITY OF PROVISIONS

A. Should any section of provision of this ordinance be declared invalid, such decisions shall not affect the validity of the remaining portions of this ordinance.


SECTION 6. PENALTY

A. Anyone violating this ordinance shall forfeit Two Hundred (\$200.00) dollars and the costs of prosecution, and in default of payment of the forfeiture, upon conviction thereof, the person violating this ordinance shall be confined to the County Jail until such forfeiture with costs have been paid, not to exceed thirty days. Each day of violation shall constitute a separate offense under this ordinance.

SECTION 7. EFFECTIVE DATE

A. BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect after publication.
