

Town of Silver Cliff Ordinance No. 121405

AN ORDINANCE TO ADOPT THE TOWN OF SILVER CLIFF YEAR 2030 COMPREHENSIVE PLAN, MARINETTE COUNTY, WISCONSIN

The Town Board of the Town of Silver Cliff, Marinette County, Wisconsin, do ordain as follows:

SECTION 1. Pursuant to sections 62.23(2) and (3) for cities and villages, and for towns exercising village powers under 60.22(3) of the Wisconsin Statutes, the Town of Silver Cliff is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.

SECTION 2. The Town of Silver Cliff Plan Commission, by a majority vote and Resolution No. \_\_\_, has recommended to the Silver Cliff Town Board the adoption of the document entitled "TOWN OF SILVER CLIFF YEAR 2030 COMPREHENSIVE PLAN", Marinette County, Wisconsin as their comprehensive plan according to Section 66.1001(2) of the Wisconsin Statutes.

SECTION 3. Numerous public meetings and mailings have been facilitated in conjunction with a public participation plan with respect to town goals, public opinion and participation, including a regular meeting schedule of the Silver Cliff, Amberg, and Athelstane Joint Comprehensive Plan Committee, numerous individual meetings of the Silver Cliff Planning Commission, an Issues Workshop held November 8, 2003, public informational meetings held on November 8, 2003 and June 19, 2004, direct mail postcard notifications sent to all property owners preceding the public informational meetings held November 8, 2003 and June 19, 2004, and for the October 23, 2004 public hearing, and a public hearing held October 23, 2004. The public hearing was preceded by a Class I notice and widespread comprehensive plan document distribution in accordance with Wisconsin Statutes 66.1001(4) to facilitate plan access and to gather public comments.

SECTION 4. The Silver Cliff Town Board of Marinette County, Wisconsin, does, by the enactment of this ordinance, formally adopt the document entitled, "TOWN OF SILVER CLIFF YEAR 2030 COMPREHENSIVE PLAN", Marinette County, Wisconsin as their comprehensive plan pursuant to Section 66.1001(2) of the Wisconsin Statutes.

SECTION 5. This ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and publication as required by law.
